Know all by these present, that the undersigned hereby makes, constitutes and appoints Alvaro Garcia-Tunon and David M. Seitz, as the undersigned's true and lawful attorneys-in-fact, with full power and authority as hereinafter described on behalf of and in the name, place and stead of the undersigned to:
